ANNOUNCEMENT OF OPENING OF AN INTERNATIONAL SELECTION CONTEST PROCEDURE FOR CONTRACTING A DOCTOR UNDER ARTICLE 23 OF THE DECREE-LAW N.º 57/2016, OF 29TH AUGUST

Aviso (extrato) n.º 20119/2021 (2ª série), de 25 de outubro

1. By order dated October 8 th 2021 of the Rector of the University of Évora, it was deliberated to open an international selection contest for the position of Doctoral Researcher for the exercise of scientific research activities in the scientific area of Architecture under a fixed-term public employment contract for a period of 36 months, pursuant to Decree-Law No. 57/2016, of 29th August and the Regulation for the Evaluation of the Performance of Doctoral

Responsible to at the Horizontal Private Priva

The researcher must carry out research in the scientific area of architecture, which includes, among others, the following tasks

- a) Survey, structure, systematize, register, identify and recognize the cultural values present and fundamental to the definition of a theoretical and patrimonial framework of Malagueira;
- b) To collect, systematize, register and archive in databases (written, drawn and photographic) Malaqueira (built and not built) in articulation with existing archives (national and foreign).
- c) To consolidate the existing documentary and theoretical frameworks, to carry out/complement a systematic bibliographical analysis, to elaborate comparative models/syntheses with the historic centre of Évora and other examples.
- d) To simulate through three-dimensional virtual models (augmented reality and/or virtual reality) the unbuilt Malagueira in comparison with reality.
- e) To produce, transfer, promote and disseminate the collected and produced knowledge through articles and communications, to dynamize partnerships, to implement events (scientific, cultural, educational and artistic), such as exhibitions and workshops.
- f) To map, register and systematize a Heritage Chart for Malagueira, to present a diagnosis of the existing situation and to define operational guidelines for its safeguarding.
- g) To develop initiatives that contribute to the recognition and identification of Malagueira's value by the inhabitants and tourists of Évora.
- h) To participate in the activities of the Research Group on Architecture of the Centre for History of Art and Artistic Research (CHAIA).

The researcher may be in charge of teaching service, up to a maximum of 4 hours per week, in the curricular units distributed to him/her.

- 2. Applicable legislation: Decree-Law no. 57/2016 of 29th August, which approves the doctor hiring regime destined to stimulate scientific and technological employment in all areas of knowledge (RJEC). General Public Service Labour Law (Lei Geral do Trabalho em Funções Públicas, LTFP), approved in annex to Law no. 35/2014 of 20 June, under its current wording.
- 3. Pursuant to article 16 of Decree-Law no. 57/2016 of 29th August, this contest procedure shall be exempt from authorization by the Government members in charge of the areas of Finances and Public Administration, namely that mentioned in n° 3 of article 7 of the LTFP; from obtaining a prior favourable opinion from the Government members in charge of the

areasetifile in the recruitment process for workers in a requalification position, mentioned in article 265 of the LTFP.

4. Pursuant to article 13 of the RJEC, the contest selection panel has the following composition:

Soraya Genin (Prof^a Auxiliar, Escola de Tecnologias e Arquitetura, ISCTE - Instituto Universitário de Lisboa).

- 5. The workplace is located at the Centre for History of Art and Artistic Research (CHAIA), Palácio do Vimioso, Largo Marquês de Marialva, nº 8 I 7002-554 Évora.
- 6. The monthly remuneration to be paid is 2 134,73€ corresponding to level 33 of the Single Salary Table, approved by Order no. 10-B/2020 of 20th March.
- 7. Admissibility: National, foreign and stateless candidates may apply to the competition if they hold a degree in architecture and a PhD in Architecture and if they possess a scientific and professional curriculum that reveals a profile adequate to the activity to be developed, with
- i) Experience in research and scientific production;
- ii) A minimum of 5 years of professional experience in architecture;
- iii) High level of written and spoken communication skills in Portuguese and English.

If the PhD degree was awarded by a foreign higher education institution, candidates are admitted to the call, according to paragraph e) of n°. 2 of article 4 th of Decree-Law no. 60/2018, of August. The registration/recognition of the degree in Portugal must be carried out after the end of the competition, under the terms provided for in the Decree-Law n°. 66/2018, of 16 August, which is only necessary when hiring.

- 7.1. According to the requirements, the Jury may decide to preliminarily exclude candidates who, in absolute merit and considering the overall curriculum in all its aspects, do not fall within the disciplinary area or areas to which the competition refers or do not reach the level of quality compatible with the category for which the competition was opened.
- 8. The general requirements for admission to the competition are those defined in article 17 of LTFP and the particular preferential requirements defined in the previous point.

- 9. An அள்ளுர்க்கு it article 5 of RJEC, selection is made through an evaluation of the candidates' scientific and curricular background.
 - 10. The evaluation of the scientific and curricular background focuses on relevance, quality and timeliness:
 - a) Research experience and scientific production in the area of architecture;
 - b) Professional experience in architecture (in project production and authorship, in architectural and/or artistic creation, and in project analysis and evaluation);
 - c) Capacity for organizing knowledge dissemination activities in the last 5 years, namely in the context of promoting architectural culture and scientific practices, considered of greater relevance by the candidate.
 - 11. The periods referred to in the previous number may be increased by the jury, at the candidate's request, when based on suspension of scientific activity for socially protected reasons, namely for reasons of parental leave, prolonged serious illness, and other situations of unavailability for work that are legally protected.
 - 12. The final classification system of the candidates is expressed from 0 to 100. The value is calculated by weighing each factor as follows and bearing in mind that it is intended to select a researcher capable of developing research on Malagueira as heritage:
 - 1. 1. Research experience and scientific production: weighting 40%:
 - Academic background and complementary training. In this
 parameter the candidate's academic background must be evaluated,
 as well as the training courses and conferences in which he/she has
 participated.
 - 2. Participation in scientific projects with national and/or international funding. In the assessment of this parameter, the participation as project leader researcher should be taken into account.
 - 3. Scientific production. This parameter should evaluate books, chapters in books, articles in scientific journals and in minutes of conferences, colloquia, congresses, international and national seminars; organisation of national and international scientific events, with and without ISBN.
 - 4. Scientific recognition. In this parameter the awarded prizes and research scholarships, participation in scientific events (with peer review), evaluation and review of national and international scientific publications should be evaluated.
 - 2. Professional experience in architecture: weighting 30%:

 1. Production and authorship of project and works in architecture,
 heritage and urbanism. In this parameter the level of involvement in
 the project should be considered (authorship, collaboration).
 - Cultural and artistic production in the field of architecture. In this parameter the level of involvement (curatorship, participation, collaboration) should be considered.
 - 3. Architectural, cultural and artistic recognition. In this parameter the awarded prizes, selection of works by peers for publication or exhibition should be considered.
 - 4. Experience in the analysis and evaluation of architectural projects.
 - 3. Knowledge dissemination/transmission activities: weighting of 30%. In this parameter, exhibitions, conferences and other activities of dissemination and transmission of knowledge related to architecture should be considered.
- 13. The jury may invite candidates it considers that further clarifications on the candidates' profile are necessary. The interview may take place offline, through a digital platform, and must be recorded for joint evaluation by the jury and with the candidate's written consent.
- 14. The jury deliberates by means of a reasoned roll-call vote according to the selection criteria adopted and disclosed; abstentions are not allowed.
- 15. Minutes of the jury meetings shall be written, containing a summary of what occurred in them, as well as the votes issued by each member and respective reasoning, and they shall be made available to the candidates whenever requested.
- 16. After concluding the application of the selection criteria, the jury shall prepare the ordered list of the approved candidates with the respective classification.
- 17. The jury's final deliberation is homologated by the institution's top manager who is also responsible for deciding on the hiring.
- 18. Formalization of the applications
- 18.1. The applications must be formalized upon request, available at the website of the

Administrative Services of the University of Évora (http://www.sadm.uevora.pt), and addressed to the President of the Evaluation and Selection Panel, which must include the identification of this announcement (Ref^a CHAIA-02), full name of the candidate, parents' names, ID or Citizen Card number and date, taxpayer ID number, date and place of birth, marital status, occupation, residence and contact address, including email address and telephone contact.

18.2. The application is accompanied by the documents that prove the conditions established in items 7 and 8 for admission to this competition, namely:

- 1. 1. Letter of motivation;
 - Documents proving the fulfilment of the admissibility conditions, namely a copy of the certificate or diploma of all the degrees listed on the curriculum;
 - 3. Detailed curriculum, structured in accordance with the provisions of item 12;
 - 4. Other documents that the candidate considers pertinent.
- 18.3. All documents must be submitted in Portuguese.
- 18.4. Foreign applicants, except those of Portuguese-speaking countries, must submit an officially recognized document proving their written and oral Portuguese language proficiency.
- 18.5. Candidates shall submit their applications and supporting documents, in digital support, in PDF format, digitally signed, to the email address drhsc@uevora.pt.
- 19. Candidates are excluded from admission to the competition if they formalise their application incorrectly or do not prove the requirements of the present competition. In case of doubt, the jury has the right to ask any candidate to produce documents to support their statements.
- 20. False statements made by the candidates shall be punished in accordance with the law.
- 21. The list of admitted and excluded candidates as well as the final ranking list shall be published on the website http://www.sadm.uevora.pt and candidates shall be notified by e-mail with receipt of notification.
- 22. Prior hearing and deadline for the final decision: In accordance with article 121 of the Administrative Procedure Code, after being notified, the candidates have 10 working days to state their opinion. The jury's final decisions are taken within 90 days, counting from the deadline for the presentation of applications.
- 23. The present competition is exclusively aimed at filling the indicated vacancy and can be terminated until the homologation of the final ranking list of the candidates and expires with the respective occupation of the job position on offer.24. 
