OFFER DESCRIPTION

It is hereby made public that for 30 working days counted from the first working day following the publication of this Edital in Diário da República, an international position is open for the recruitment of one Full Professor, in the disciplinary area of Geography at the School of Science and Technology of the University of Évora, as established in articles 37.º to 51.º, 61.º and 62.º-A of the ECDU (DL nº205/2009, of August 31st) and further applicable laws and regulations, particularly the Regulamento dos Concursos para Recrutamento de Professores das Carreiras Docentes na Universidade de Évora, henceforth called Regulamento, approved by the Despacho n.º 2433/2019, published in the 2nd Series of Diário da República, nº 49, of March 11.

The joint order nº 373/2000, of March 31th, made compulsory the inclusion of the following reference in all civil service recruitment procedure notices:

 "As established in item h) of article 9.º of the Portuguese Constitution, Public Administration, when acting as an employer, actively promotes a policy of equal opportunity between men and women in access to employment and in professional progression, scrupulously endeavouring to avoid any form of discrimination".

In accordance with articles 37º to 51º of the ECDU and other applicable legislation and with article 8º of the Regulamento, the following provisions will apply:

I - Authorization order - the present open position was authorized by order of the Rector of the University of Évora, on

II - Place of work: University of Évora

III - Admission requirements:

III.1. Chapter IV of the Regulamento is applied in regard to verification and compliance of the requirements of admission and exclusion of the candidates.

III.2. Under the terms of article 40 of the ECDU, can only be admitted to the present call, who holds a PhD in Geography or related areas, for more than 5 years, at the deadline of the application, who simultaneously holds the "Agregado" title in the area of this call and is proficient in the Portuguese language, both spoken and written.

III.3. If the PhD degree has been awarded by a foreign higher education institution, the candidates are admitted, according to paragraph e) of nº2 of article 4th of Decreto-Lei nº 60/2018, of August 3 and the registration/recognition of the degree in Portugal must be carried out after the end of the competition, under the terms set out in Decreto-Lei nº 66/2018, of August 16th, being a requirement for the act of signature of the contract.

III.4. Foreign candidates, except those of an official portuguese expression, are required to provide an officially recognized statement, demonstrating that they master the Portuguese language, in both written and spoken forms.

IV — Admission requirements in absolute merit:

IV.1. Article 12º of the Regulamento is applied with regard to admission in absolute merit of candidates.

IV.2. The jury will deliberate on the approval or rejection in absolute merit, through justified nominal voting, where abstentions are not allowed. Approval in absolute merit is understood as receiving a positive vote of more than half of the voting jury members.

IV.3. The approval in absolute merit is considered on the overall curriculum, that the jury considers to have scientific merit, research capacity and value of the pedagogical activity already developed, compatible with the area or disciplinary areas to which the position respects, and appropriate to the respective category and the fulfillment at least two of the following requirements set by the Scientific Council of the University of Évora, under the terms of despacho No. 124/2020, of 22 October:

V - Evaluation parameters and ranking in relative merit, weighting and final assessment:

V.1. The method of selection is curricular evaluation. This curricular evaluation, takes into account the general functions committed to the teachers by article 4th and according to n° 6 of article 50th of the ECDU, is based on the following items:

- a) Research;
- b) Teaching;
- c) Knowledge transfer,
- d) Academic management activities;
- e) Scientific and pedagogical project.

V.2. In the application of the criteria defined in number V.1., the following parameters and weights will be used:

- a) Research, with weight of 35%, which comprises:
 - a1) Scientific, cultural, artistic or technological production and its relevance in the disciplinary area in which the position is open;
 - a2) Participation and coordination of research projects and their relevance in the disciplinary area in which the position is open;
 - a3) Other scientific, cultural, artistic or technological activities;
- b) Teaching, with weight of 25%, which comprises:
 - b1) Teaching experience (curricular units taught, teaching hours and assessment by students);
 - b2) Student supervision;
 - b3) Publication of textbooks with ISBN and of other educational texts;
 - b4) Educational innovation;
- c) Knowledge transfer, with a weighting factor of 10% and comprising the following parameters:
 - c1) Intellectual and industrial property

c3) Training actions

c4) Non-academic experience relevant to the subject area of the competition

d) University management activities with a weighting factor of 10%

e) Scientific and pedagogical project, with a weighting factor of 20%, to fit within the scope of the development of the anchor areas of the University of Évora presented in the following terms:

e1) maximum of 5 thousand (5000) words;

e2) submit a concise research proposal and a strategy for training in the disciplinary area of the competition highlighting the innovative nature of the project, its relationship with the University's strategy, as well as its potential interaction with other research units or organic units of the University, especially the School of Science and Technology. The scientific aspect must be related to the pedagogical component that the candidate intends to implement;

e3) Framing the project in terms of state of the art, materials / data, methods and results;

e4) Submit a strategy for attracting human resources and financing that supports the development and consolidation of the proposed research strategy. The candidate must relate the proposal to previous results of his investigation that can support it;

e5) contain a brief summary of the most recent bibliographic references as well as a summary conclusion of the expected results.

V.3. It is a preferential factor specialization in Environment and Territorial Planning and Analysis of Public Policies and/or Spatial Modeling.

V.4. The jury will proceed with the evaluation of the candidates approved in absolute merit, following the procedure expressed down in article 22nd of the Regulamento.

V.5. The ranking of the candidates will be the result of the weight average of quantitative scores obtained in each of the evaluation parameters, within a range of 0 to 100 points.

VI – Public hearings:

VI.1. The jury will deliberate at the first meeting on the need to hold public hearings of all candidates approved in absolute merit which are intended, in an exclusive way, to clarify what appears in the curriculum vitae submitted by the candidates, under the terms of b), nº 4 of article 50º of ECDU, with all candidates being informed, at least five working days in advance, of the date and place where such hearings will take place.

VI.2. Public hearings referred to in the previous paragraph may be held by videoconference, but the jury must guarantee that these are carried out on equal terms for all candidates.

VI.3. According to paragraph a), nº 4 of article 50º of ECDU the jury may also to request candidates to provide additional documentation related to the submitted curriculum.

- a) Certificates showing that the candidate holds the degree and the title required to apply as well as the dates they were obtained, in pdf format.
- b) Certification of the time of service issued by the service if there is a contract with the public administration, in pdf format.
- c) Two copies in paper, duly signed and dated, and one in pdf format of the candidate's curriculum vitae, with indication of the articles and other work done and published, as well as identification of those that she/he considers most representative, for which a brief description of her/his contribution is required. The curriculum vitae must also indicate her/his educational activities developed. In the curriculum vitae the candidate must respect the organization used in V.2 of this Edict.
- d) Two copies, in paper format, and one in pdf format, of the works selected by the candidate as most representative in her/his curriculum vitae, up to a maximum of five works.
- e) A digital copy (PDF) of the scientific-pedagogical project;
- f) Other diplomas or certificates of studies referred in the curriculum vitae, in paper and in pdf format.

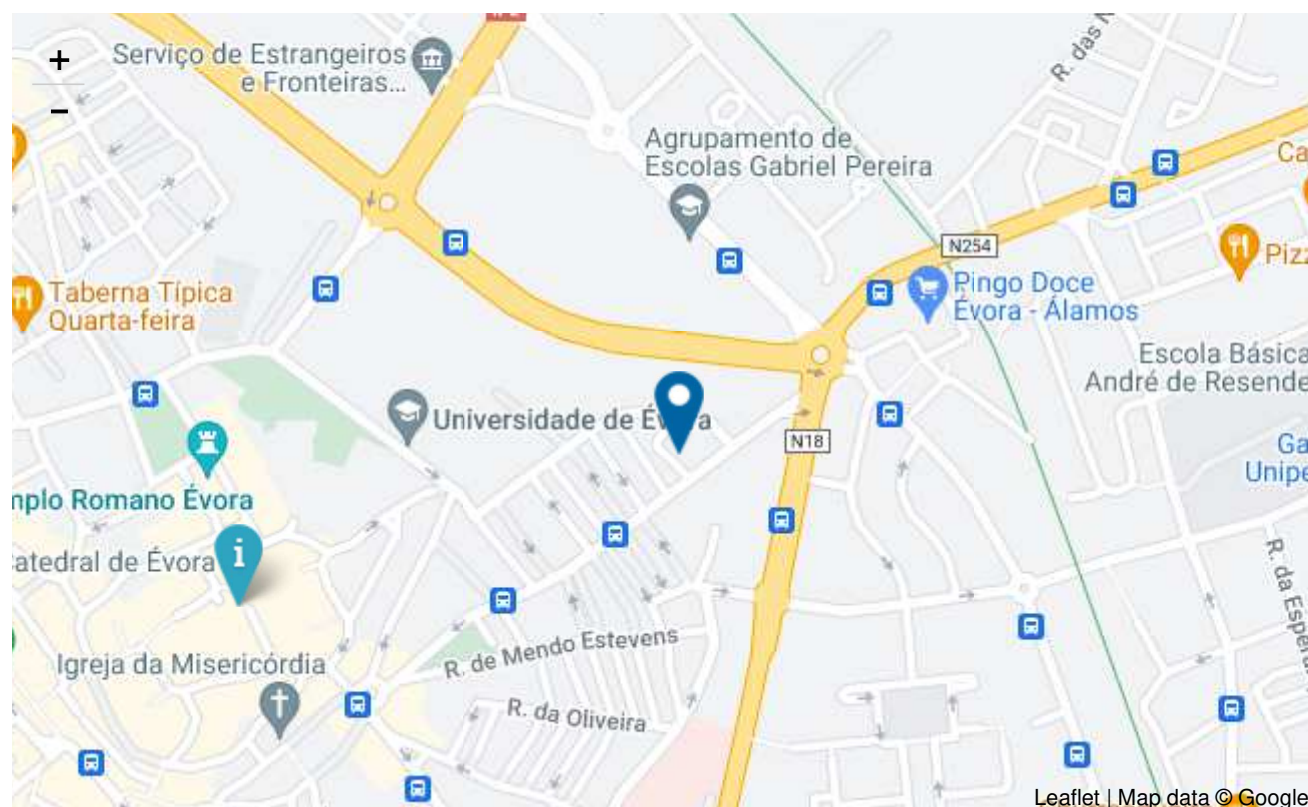
